**RATIFICATION OF THE APPROVAL OF APPLICATIONS BY THE BOARD  
FOCAL PERSON ON THE ACCREDITATION OF SCHOOLS TO OFFER  
REFRESHER COURSE PURSUANT TO RESOLUTION NO. 05 (S. 2021)  
FOR THE MONTHS OF NOVEMBER AND DECEMBER 2021**

**WHEREAS**, on May 31, 2021, the Professional Regulation Commission (Commission) and the Professional Regulatory Board of Criminology (Board) issued Resolution No. 05 (s. 2021), entitled "Guidelines in the Conduct of Refresher Course as a Requirement under Section 14, Rule II of Republic Act No. 11131 and its Implementing Rules and Regulations";

**WHEREAS**, Section 7 of Resolution No. 05 (s. 2021) provides that applications for the accreditation of schools to offer refresher course shall be processed and approved by a member of the Board duly designated as the Focal Person;

**WHEREAS**, Section 8 of Resolution No. 05 (s. 2021) also provides that, upon confirmation of the approved applications by the Board, it shall issue a Certificate of Accreditation with a validity period of five (5) years from the date of issuance and shall accordingly inform the qualified educational institution of such approval;

**WHEREAS**, during its August 12, 2021 regular monthly Board meeting, the Board approved the designation of **WARREN M. CORPUZ** as the Board Focal Person to approve applications for the said accreditation;

**WHEREAS**, pursuant to Memorandum Order No. 04 (s. 2016) issued by the Commission on the "Streamlining of Procedures in the Preparation of Board and Commission Resolutions and other Official Issuances involving Policy Decisions and Directives; Actions and/or Decisions on Applications for the Licensure Examination, Registration without Examination, Issuance of Certificates of Accreditation, Certificates of Compliance (COCs), Certificates of Authority to Operate, Certificates of Registration of Corporations and Partnerships for the Practice of Profession and other Similar Applications," all applications approved by the Board Focal Person shall be subsequently ratified by the Board and the Commission through a Resolution issued for the purpose;

**WHEREAS**, the following applications for accreditation of the following schools to offer refresher course as required under Section 14 of the Implementing Rules and Regulations of Republic Act (R.A.) No. 11131, have been approved by the Board Focal Person for the months of November and December 2021:
