**REVERTING TO THE PREVIOUS DESIGN OF THE TROPHY FOR THE
OUTSTANDING PROFESSIONAL OF THE YEAR AWARD**

WHEREAS, Republic Act No. 8981 also known as “*The PRC Modernization Act of 2000*” recognizes the important role of professionals in nation-building, and towards this end, promotes the sustained development of a reservoir of professionals whose competence has been determined by honest and credible licensure examination and whose standards of professional service and practice are internationally recognized and considered world-class brought about by the regulatory measures, programs and activities that foster professional growth and advancement;

WHEREAS, Proclamation No. 118 (s.1987) was issued declaring the period from June 16 to June 22 of every year as Professional Regulation Week under the auspices of the Professional Regulation Commission (Commission), the Professional Regulatory Boards and the Professional Associations;

WHEREAS, in 1997, the Commission started to confer the “**OUTSTANDING PROFESSIONAL OF THE YEAR**” Award to exceptional professionals to recognize their excellent achievements in their respective professions and their significant contributions and services to fellow professionals, the profession and the nation;

WHEREAS, prior to the 2014 awarding ceremony, a glass trophy bearing the PRC logo was given to the Outstanding Professional Awardees;

WHEREAS, the Commission issued Resolution No. 2014-842 dated 17 June 2014 changing the design of the Outstanding Professional of the Year Award trophy to be awarded;

WHEREAS, Memorandum Circular No. 12 dated 27 November 2017 with the subject: *Selection of the Outstanding Professional of the Year, the Outstanding Accredited Professional Organization of the Year and the Nubla Excellence Awardee for the year 2018* provides for the composition of the Screening and Selection Committee for Outstanding Professional of the Year Award (Committee);

WHEREAS, on 05 March 2020 the Committee met and agreed to recommend to the Commission to revert to the previous design of the trophy for the Outstanding Professional of the Year Award (**Annex “A”**) which better highlights the Commission as the originator of the prestigious award and at the same time possesses a simplistic and minimalistic design for a token which has timeless elegance and appeal that any professional would be proud to receive, own and display;

WHEREAS, the Committee issued Resolution No. 01 dated 20 March 2020 (**Annex “B”**) recommending to the Commission the reversion to the previous design of the trophy for the Outstanding Professional of the Year Award used prior to Resolution 2014-842;

NOW, THEREFORE, the Commission hereby **RESOLVES** to approve the recommendation to revert to the previous design of the trophy, as follows:

Section 1. Design of the Trophy – The solid glass, lined with gold, cut to rise on a solid base with the PRC seal above center.

In Solid Glass

The solid glass represents transparency, openness, and solidity of achievement that makes life shine amidst human imperfection.

Transparency is reflective of an attitude of professionalism.

Openness contemplates scrutiny demonstrated by peers and change, reflecting a lifetime spent in learning and self-improvement.

Lined with Gold

The gold lining symbolizes the reward of professional service rendered with competence and excellence, integrity and fairness, and faithfulness to the public served and to the code of ethics.

Cut to Rise

Cut with a sharp edge on one side for being sharpened on the anvil of education but rounded on the other side to show the balance of professional training with a well-rounded person seasoned by productive experience.

Rising above personal circumstances to face the challenge of serving the clients of his/her chosen profession amidst the technological revolution of the new millennium.

Printed upwards to reflect that all excellent human effort and achievement is a reflection of the creator.

The moon that guides with light.

Leading the professional to the learning and ever path of global competitiveness.

Section 2. Adoption of the Design – The design of the trophy for the Outstanding Professional of the Year Award shall be adopted starting the 2020 Awards Night and the succeeding years thereafter.

FURTHER, the Commission hereby **RESOLVES** to use the recommended design of the trophy starting on the 2020 Awards Night and on the succeeding years thereafter.

This Resolution shall take effect upon approval.

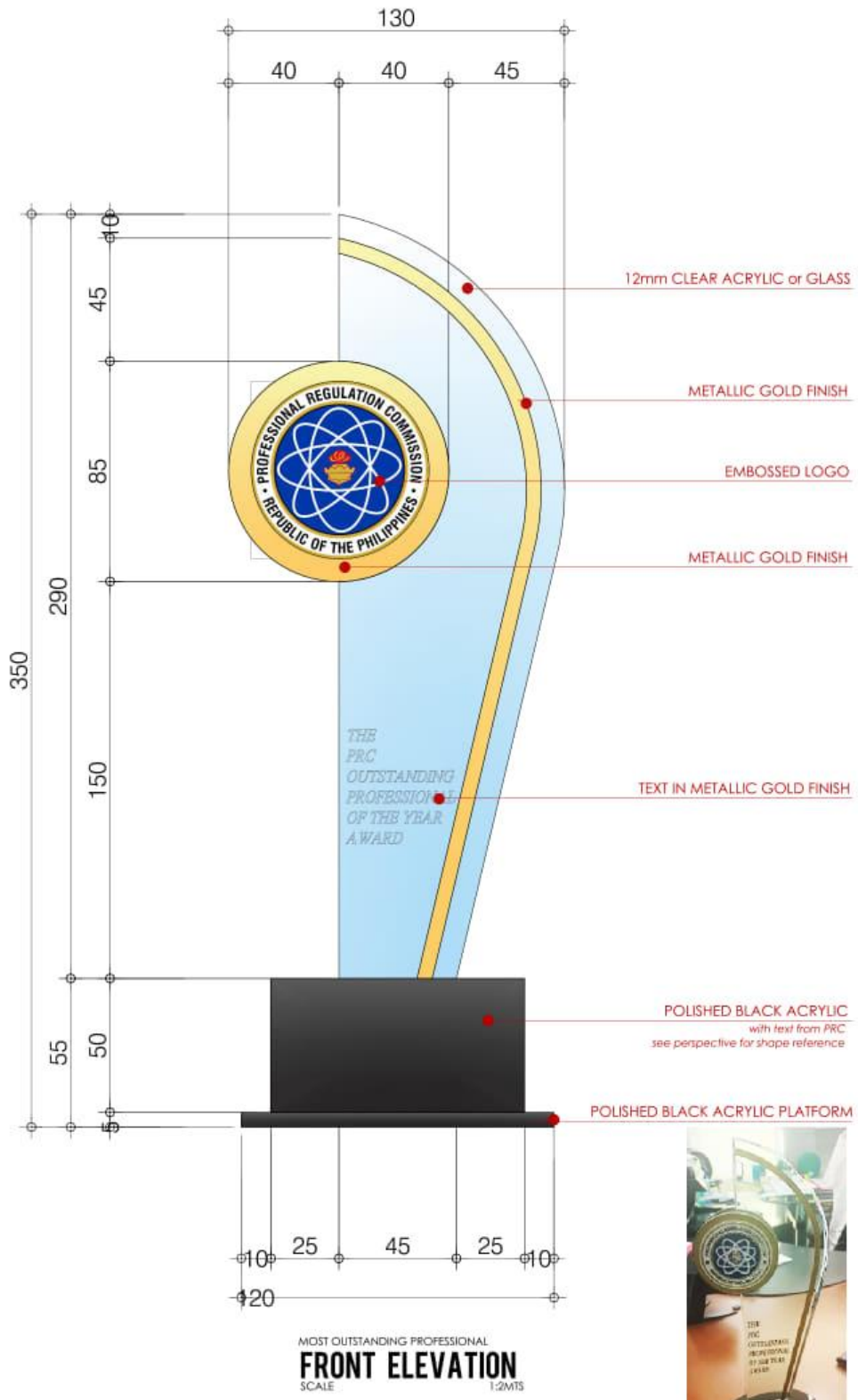

WHEREAS, the Professional Regulation Commission issued Memorandum Circular No. 12 dated November 27, 2017 with the Subject: Selection of the Outstanding Professional of the Year," the Outstanding Accredited Professional Organization of the Year and the Nubla Excellence Awardee for the year 2018, the said circular was disseminated this year for the said awards;

WHEREAS, the circular provides for the composition of the Screening and Selection Committee for Outstanding Professionals of the Year Award, as follows:

- A representative of the Commission Proper;
- Chairman or member of the concerned PRB;
- President of the Foundation for Outstanding Professionals (FOP) or his/her representative;


