**REOPENING OF THE ONLINE APPLICATION SYSTEM FOR THE DECEMBER
2021 GEODETIC ENGINEERS LICENSURE EXAMINATION
FROM OCTOBER 20, 2021 UNTIL NOVEMBER 22, 2021**

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1283 (s. 2020) scheduling the Geodetic Engineers Licensure Examination (GELE) on October 06 & 07, 2021, to be held in Baguio, Cebu, Manila, and Tuguegarao and setting the deadline for the filing of applications on September 06, 2021;

WHEREAS, the Commission issued Resolution No. 1414 (s. 2021) designating Davao, Legazpi, Tacloban, Pagadian, and Zamboanga as additional testing centers for the October 2021 GELE to allow examinees to take the licensure examination without incurring additional travel expenses;

WHEREAS, the Commission, through Resolution No. 1419 (s. 2021), extended the deadline for the filing of October 2021 GELE applications until September 20, 2021;

WHEREAS, upon request by relevant stakeholders, Resolution No. 1433 (s. 2021) was subsequently issued by the Commission rescheduling the October 2021 GELE from October 06 & 07, 2021 to December 22 & 23, 2021;

WHEREAS, in view of the said rescheduling, the Caraga State University of Butuan City, the Visayas State University of Baybay City, the Leyte and Eastern Visayas State University of Tacloban City and those graduates who failed to submit their applications within the deadline have submitted requests for the re-opening of the application period citing as reasons, among others, rescheduled date of graduation, lack of awareness on additional testing centers, and other COVID-19 related restrictions;

WHEREAS, considering the above reasons, the Professional Regulatory Board of Geodetic Engineering and the Licensure Office recommend to the Commission to reopen the December 2021 GELE Online Application from October 20, 2021 to November 22, 2021 to afford prospective examinees the opportunity to take the 2021 December GELE;

WHEREFORE, the Commission **RESOLVES**, as it hereby **RESOLVED**, to **REOPEN** the Online Application System for the **December 2021 Geodetic Engineers Licensure Examination** from **October 20, 2021 until November 22, 2021**;

RESOLVED FURTHER, that necessary coordination shall be undertaken by the appropriate offices/divisions of the Commission for proper dissemination of information.
