RESCHEDULING THE NUTRITIONIST-DIETITIANS LICENSURE EXAMINATION TO NOVEMBER 23 AND 24, 2023, AND FIXING A NEW APPLICATION PERIOD AND TARGET DATE OF RELEASE OF EXAMINATION RESULTS

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1589 (s. 2022) scheduling the Nutritionist-Dietitians Licensure Examination (NDLE) on October 08 and 09, 2023, the period of filing of applications from July 07, 2023 to September 08, 2023, and the target date of release of examination results on October 11, 2023;

WHEREAS, the Commission received requests to reschedule the conduct of the NDLE to accommodate the new graduates who will not be able to complete their application documents on or before the deadline of the filing of applications on September 08, 2023;

WHEREAS, considering that the NDLE is conducted only once a year, the Professional Regulatory Board of Nutrition and Dietetics (Board) recommends the approval of the request to give the new graduates the opportunity to take the NDLE without having to wait the following year;

WHEREAS, the proposed schedule shall afford the applicants ample opportunity to prepare and submit their documentary requirements to the Commission;

WHEREFORE, premises considered, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **RESCHEDULE THE NUTRITIONIST-DIETITIANS LICENSURE EXAMINATION**, to wit:

August 23, 2023	October 24, 2023	November 23 & 24, 2023	November 28, 2023

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
