**RESOLUTION NO. 1434**

**CANCELLING THE OCTOBER 2021 FORESTERS LICENSURE  
EXAMINATION IN PRC-ROSALES**

**WHEREAS**, Section 7 (d) of Republic Act No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

**WHEREAS**, the Commission issued Resolution No. 1283 (s. 2020) scheduling the Foresters Licensure Examination (FLE) on August 12 & 13, 2021, to be held in the National Capital Region (NCR), Baguio, Cagayan de Oro, Cebu, Davao, Iloilo, Legazpi, Lucena, Pagadian, Pampanga, Rosales, Tacloban, Tuguegarao, and Zamboanga;

**WHEREAS**, the Commission issued Resolution No. 1345 (s. 2021) postponing the August 2021 FLE and rescheduling the same to October 20 & 21, 2021 and setting the deadline for filing of applications on September 20, 2021;

**WHEREAS**, the Commission also issued Resolution No. 1428 (s. 2021) extending the deadline for the filing of October 2021 FLE applications to October 05, 2021;

**WHEREAS**, per record of the processed October 2021 FLE applications, only two (2) applicants were registered in PRC-Rosales;

**WHEREAS**, with the low turnout of examinees in PRC-Rosales and for economic, logistical, and manpower conservation purposes, the concerned regional director recommended the cancellation of the October FLE in their region in order for PRC-Rosales to be able to conserve its resources for other equally significant and crucial services;

**WHEREAS**, upon coordination with the nearest Regional Offices for the transfer of exam venue by the affected examinees, PRC-Baguio and PRC-San Fernando [Pampanga] will accommodate the two (2) examinees subject to the latter's compliance to the imposed local government unit's protocols on entry and in the conduct of licensure examination;


**WHEREAS**, in view of the foregoing, the Professional Regulatory Board of Foresters and the Licensure Office recommend to the Commission the cancellation of the October 2021 FLE in Rosales;

**WHEREFORE**, premises considered, the Commission **RESOLVES**, as it hereby **RESOLVED**, to **CANCEL** the conduct of the **October 2021 Foresters Licensure Examination in Rosales**;

**RESOLVED FURTHER**, that the Foresters Licensure Examination shall proceed as scheduled in the **NCR, Baguio, Cagayan de Oro, Cebu, Davao, Iloilo, Legazpi, Lucena, Pagadian, Pampanga, Tacloban, Tuguegarao, and Zamboanga** on October 20 & 21, 2021.
