DESIGNATING CAGAYAN DE ORO, CEBU, AND ILOILO AS ADDITIONAL TESTING CENTERS FOR THE REAL ESTATE CONSULTANTS LICENSURE EXAMINATION IN DECEMBER 2021 (WRITTEN) AND JANUARY & FEBRUARY 2022 (REVALIDA)

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and **to determine and fix the places and dates of examinations**;

WHEREAS, the Commission issued Resolution No. 1283 (s. 2020) scheduling the Real Estate Consultants Licensure Examinations (RECLE) on February 14, 2021 & December 09, 2021 (Written) and February 15-19, 2021 (Revalida);

WHEREAS, the February 2021 RECLE was rescheduled to July 21, 2021 (Written) & July 22-26, 2021 (Revalida) by virtue of Resolution No. 1303 (s. 2021);

WHEREAS, Resolution No. 1372 (s. 2021) was issued postponing the July 2021 RECLE (Written and Revalida) and rescheduling the same to December 9, 2021 (Written) and January 2022 (Revalida);

WHEREAS, the Commission received a letter from Director Julie L. Sabalza of PRC-Cagayan de Oro, Director Narcival Randie Z. Taquiqui of PRC-Cebu, and OIC-Director Joy S. Jalbuena of PRC-Iloilo endorsing the requests of the stakeholders to include their provinces as additional testing centers to accommodate and cater examinees;

WHEREAS, the PRC Regional Offices of Cagayan de Oro, Cebu, and Iloilo assured that they have the budgetary requirements, supplies, and manning complement for the conduct of the December 2021 (Written) and January & February 2021 (Revalida) RECLE;

WHEREAS, in view of the health measures imposed by the government to mitigate, if not contain, the spread of COVID-19 through, but not limited to, social distancing and travel restrictions from one place to another, the Professional Regulatory Board of Real Estate Service endorsed the inclusion of Cagayan De Oro, Cebu, and Iloilo as testing centers for the welfare of the prospective examinees from their province, allowing them to take the RECLE without unnecessary distant travel and additional expenses;


WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to designate **CAGAYAN DE ORO, CEBU, and ILOILO** as additional testing centers for the **December 2021 Real Estate Consultants Licensure Examination (Written) and January 3-7, 10-14, 17-21, February 7-11, 14-18, 21-25, 2022 (Revalida)**;

RESOLVED FURTHER, that necessary coordination be undertaken by the appropriate offices/divisions of the Commission to ensure the smooth and orderly conduct of said licensure examination in this testing center.
